# REPORT ON THE 16 DAYS ACTIVITISM AGAINST GENDER-BASED VIOLENCE, NOVEMBER-DECEMBER 2023.

# Introduction

- 1. Community Workshops: Sessions were conducted to educate residents on the warning signs of potential assailants and ways to protect themselves.
- 2. Interactive Discussions: Open forums allowed participants to share experiences and discuss strategies to counteract threats.
- 3. Advocacy Campaigns: Public awareness efforts, including social media, posters, and town hall meetings were used to spread the message
